## **NUMBER OF POSITIONS AVAILABLE:** Two (2)

**<u>DUTIES</u>**: Under direction of a supervisory official in the Technical Services Bureau, assists in the formation, development, implementation, and quality control of the various manual, mechanical, and data processing systems of the organization; assists in the coordination of all data processing activities for the analysis of gaming devices. The successful candidate will be responsible for testing slot machines and other electronic gaming equipment including computerized monitoring systems for compliance with New Jersey regulations and a determination of suitability for use in a New Jersey casino. Such review may include a mathematical analysis, as well as computerized and manual tests.

## **REQUIREMENTS**

**NOTE:** A Bachelor's degree in Computer Science or Computer Engineering is preferred.

**EXPERIENCE:** One (1) year of experience in work involving the review, analysis, and evaluation of the administrative, business, and/or operational policies, procedures, practices, and processes and/or the technological requirements of an organization for the purpose of revising/enhancing existing information systems and/or developing/acquiring and implementing new IT solutions and services.
