DUTIES: Under immediate supervision of an Administrator of Investigations or other supervising investigator in the Division of Gaming Enforcement, Department of Law and Public Safety, assists in performing specific field and office work relative to financial, compliance, and enforcement functions, applicants for gaming licenses, or criminal/civil violations of other state gaming statutes; participates in extensive field and office training on the operations, procedures, and policies of the section to which the trainee is assigned. Investigations may include the review of casino accounting operations, ancillary companies transacting business with the casinos, and Information Technology controls for compliance with New Jersey regulations.

REQUIREMENTS
