Petitioner, State of New Jersey, Department of Law and Public Safety, Division of Gaming Enforcement ("Division"), located at 1300 Atlantic Avenue, Atlantic City, New Jersey, 08401 says:

1. Respondent, QUANG K. BUI ("Bui"), is a New Jersey resident, and currently resides at 14 Ransome Place, Plainfield, NJ 07063.

2. N.J.A.C. 13:69G-1.3(a)3 authorizes the exclusion from a licensed casino establishment of:

Any person who has been convicted of a criminal offense under the laws of any state, or of the United States, which is punishable by more than six months of incarceration, or who has been convicted of any crime or offense involving moral turpitude, and whose presence in a licensed casino establishment would be inimical to the interest of the State of New Jersey or of licensed gaming therein.

3. N.J.A.C. 13:69G-1.3(a)4 authorizes the exclusion of any person:

whose presence in a licensed casino establishment would be inimical to the interest of the State of New Jersey or licensed gaming therein, including

iii Persons who pose a threat to the safety of the patrons or employees of a casino licensee

iv. Persons with a documented history of conduct involving the undue disruption of the gaming operations of casino licensees

4. On February 9, 2010, Bui was convicted of 3<sup>rd</sup> degree Burglary, in violation of N.J.S.A 2C:18-2a(1) and was sentenced to three years of probation.

5. On August 17, 2012, Bui was convicted of 3<sup>rd</sup> degree Computer Theft, in violation of N.J.S.A. 2C:20-25c and was sentenced to 2 years of probation. The basis for this conviction was Bui's theft of electronically downloadable credits

belonging to other patrons while playing on slot machines at the Golden Nugget. As a condition of his probation Bui was ordered to stay out of Atlantic City casinos.

6. Bui's convictions discussed in Paragraphs 4 and 5 of this Petition are for offenses punishable by more than six months incarceration.

7. Based on the information set forth in Paragraphs 1 through 6 of this Petition, Bui has been convicted of an offense punishable by more than 6 months incarceration and is a person whose presence in a licensed casino establishment would be inimical to the interests of the State of New Jersey or licensed gaming therein and should be excluded from casino premises pursuant to N.J.A.C.13:69G-1.3(a) 3.

8. Based on the information set forth in Paragraphs 1 though 6 of this Petition, Bui is a person whose presence in a licensed casino establishment would be inimical to the interest of the State of New Jersey or licensed gaming therein and should be excluded from casino premises pursuant to N.J.A.C. 13:69G-1.3(a)4.

WHEREFORE, Petitioner demands the following relief against Respondent:

A. Judgment that Respondent, Quang K. Bui, has been convicted of an offense punishable by more than 6 months of incarceration and is a person whose presence in a licensed casino establishment would be inimical to the interest of the State of New Jersey or of licensed gaming therein, within the meaning of N.J.A.C.13:69G-1.3(a)3; and

B. Judgment that Respondent, Quang K. Bui, is a person whose presence in a licensed casino establishment would be inimical to the interest of the

State of New Jersey or of licensed gaming therein, within the meaning of N.J.A.C. 13:69G-1.3(a)4; and


C. Judgment entering a final order placing Respondent, Quang K. Bui, on the exclusion list pursuant to N.J.S.A. 5:12-71 and N.J.A.C. 13:69G-1.3(a)3; and

D. Judgment entering a final order placing Respondent, Quang K. Bui, on the exclusion list pursuant to N.J.S.A. 5:12-71 and N.J.A.C. 13:69G-1.3(a)4; and

E. Judgment for such other and further relief as the Director may deem just and appropriate under the circumstances.
