for a Social Affair Permit for an Event at the
Golden Nugget Atlantic City on May 17, 2018

ORDER
PRN1081802

Based upon a review of the Request (PRN 1081802) filed with the Division of Gaming Enforcement ("Division") on behalf of The Arc of Atlantic County ("The Arc") for a social event entitled "Dream Believe Achieve," to be held from 5:30 p.m. to 8:30 p.m., on May 17, 2018. The event will be held at the Grand Ballroom, a Casino Hotel Alcoholic Beverage ("CHAB") Type II outlet within Golden Nugget Atlantic City ("Golden Nugget"), and The Arc being a charitable organization properly registered with New Jersey's Division of Consumer Affairs, and having considered the relevant provisions of the Casino Control Act, *N.J.S.A. 5:12-1 et seq.*, I hereby **ORDER** that the Request be granted (**2018-171-SA**) with the following conditions:

1. The alcoholic beverages served at the event will be donated by Boardwalk Belle, Inc. and Harrison Beverage Company, each of which holds an Omnibus Permit issued by the New Jersey Division of Alcoholic Beverage Control ("ABC"). Alcoholic Beverages served at the event will also be donated by Black River Traders, Inc., a New Jersey licensed wholesaler, whose application for a Donation Permit is granted (**2018-172-DN**) for this event.
2. Any transportation of the alcoholic beverage inventory is to be made by the licensed wholesaler in a vehicle bearing the appropriate transit insignia issued by ABC. If The Arc, or its designee, intends to deliver the alcoholic beverages to the event, a transportation permit must be obtained from ABC, a copy of which permit shall be forwarded to the Division no later than the day before the event.

3. The storage, handling and distribution of the alcoholic beverages will be done only by members of The Arc or by duly authorized representatives of Golden Nugget. If storage of the alcoholic beverages becomes necessary, it must be stored at an authorized storage area and kept separate from Golden Nugget's own alcoholic beverages.
4. All alcoholic beverages dispensed at the event must be by the glass or other open receptacle. The alcoholic beverages are to be consumed only within the event premises. Participants at the event shall not remove any alcoholic beverages from the approved area for any reason.
5. The Arc and Golden Nugget shall be jointly and severally liable for any violations of applicable New Jersey Alcoholic Beverage laws or regulations that may arise during the event.
6. During the event, The Arc and Golden Nugget will insure that alcoholic beverages will be served only to those individuals who are 21 years of age or older and that such beverages are not served to individuals who are actually or apparently intoxicated.
7. If there is any change in the information provided in the application, prior approval must be obtained from the Division.
8. The Arc and Golden Nugget are to obtain all necessary approvals from all other governmental authorities prior to conducting this event.
9. The inventory report, attached to the Permit application, is to be filed with the Division no later than May 31, 2018. Failure to file this report may result in the denial of any future applications for social affair permits.
