#### What is an **Expungement**

It's a great opportunity! An expungement under NJSA 2C:52-1 is the removal and isolation of all records on file within any court, detention or correctional facility, law enforcement, criminal justice agency or juvenile justice agency concerning a person's apprehension, arrest, detention, trial or disposition of an offense within the criminal or juvenile justice systems. If an order of expungement is granted, the record of law enforcement taking you into custody as a juvenile, the adjudication of delinquency, the disposition and any related proceedings are considered not to have occurred. Adult arrests and convictions are handled individually.

## Which Offenses Can't Be Expunged?

Please note that some offenses cannot be expunged. They include criminal homicide, kidnapping, luring or enticing, human trafficking, aggravated sexual assault, aggravated criminal sexual contact, criminal sexual contact, criminal restraint, false imprisonment, robbery, arson and related offenses, endangering the welfare of a child, selling or manufacturing child pornography, perjury, false swearing, prostitution of a child, terrorism, producing or possessing chemical weapons, biological agents or nuclear or radiological devices, conspiracies or attempts to commit such crimes.



### When Can I Request an Expungement?

Any juvenile adjudicated delinquent may have his/her entire record of delinquency adjudications expunged if:

- Five years have passed since the final discharge, including payment of fines, from legal custody or supervision and no new offenses have occurred in the past five years.
- Youthful Drug Offender: If your conviction/adjudication was only for possession or use of a controlled dangerous substance and it occurred while you were 21 or younger, then you may be eligible for expungement after only one year. Distribution offenses are not eligible to be expunged as a Youthful Drug Offender.
