The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Health Care Claims Fraud-Third Degree)

SHLOMO COHEN

between on or about August 16, 2005 and on or about September 26, 2005, at the Town of Morristown, in the County of Morris, elsewhere, and within the jurisdiction of this Court, knowingly did make, or cause to be made, a false, fictitious, fraudulent, or misleading statement of material fact in, or knowingly did omit a material fact from, or did cause a material fact to be omitted from any record, bill, claim or other document, in writing, electronically or in any other form, and did attempt to submit, submit, caused to be submitted, or attempted to cause to be submitted said record, bill, claim, or other document for payment or reimbursement for health care services; that is, the said SHLOMO COHEN did submit or cause to be submitted a New

Jersey Hospital Care Assistance Program determination of application for participation form in order to receive Charity Care benefits, payment or reimbursement for health care services to the Morristown Hospital in the aggregate amount of \$36,570.16, said false, fictitious, fraudulent and misleading statements of material fact relating to total assets and income, contrary to the provisions of N.J.S.A. 2C:21-4.3c, and N.J.S.A. 2C:2-6 and against the peace of the State, the government and dignity of same.

COUNT TWO

(Theft by Deception-Third Degree)

SHLOMO COHEN

between on or about August 16, 2005 and on or about September 26, 2005, at the Town of Morristown, in the County of Morris, elsewhere, and within the jurisdiction of this Court, purposely obtained the property of another by deception, in an amount in excess of \$500.00, to wit \$36,570.16, by creating or reinforcing the false impression to Morristown Hospital and the New Jersey Hospital Care Payment Assistance Program (Charity Care) that his income and assets were of an amount which would entitle him to Charity Care Hospital Assistance WHEREAS IN TRUTH AND IN FACT, as the said SHLOMO COHEN well knew, his income and assets were greater than represented and would not entitle him to receive Charity Care Hospital Assistance, contrary to the provisions of N.J.S.A. 2C:20-4 and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.
