The Grand Jurors of and for the State of New Jersey, upon their oaths present that:

COUNT ONE

(Violation of the Water Pollution  
Control Act - Fourth Degree)

KEITH ROSE

on or about July 2, 2008, in the Borough of Manasquan, in the County of Monmouth, elsewhere, and within the jurisdiction of this Court, negligently and unlawfully did discharge a pollutant without a valid New Jersey Pollutant Discharge Elimination System permit issued by the Department of Environmental Protection, that is, KEITH ROSE, negligently and unlawfully did discharge a pollutant, namely oil, from the vessel Susan II, into the Manasquan Inlet and Atlantic Ocean, without a valid New Jersey Pollution Discharge Elimination System permit issued by the Department of Environmental

Protection, contrary to the provisions of N.J.S.A. 58:10A-10f(3),  
N.J.S.A. 58:10A-6a and N.J.S.A. 2C:2-6 and against the peace of  
this State, the Government and dignity of the same.


