COUNT ONE

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

RANDY E. MORETZ

on or about March 2, 2008, in the Township of Cranbury, in the County of Middlesex, elsewhere, and within the jurisdiction of this Court, did knowingly give, provide, trade, mail, deliver, transfer, publish, distribute, circulate, or disseminate, through any means, including the Internet, a photograph, computer program or file, or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act, or in the simulation of such an act, as defined by N.J.S.A. 2C:24-4b(1), contrary to the provisions of N.J.S.A. 2C:24-4b(5)(a), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

RANDY E. MORETZ


