ISHAK Y. BOUTROS )

The Grand Jurors of and for the State of New Jersey,  
upon their oaths, present that:

COUNT ONE

(Attempted Theft by Deception - Third Degree)

ISHAK Y. BOUTROS

between on or about December 3, 2007, and on or about December 4,  
2007, at the City of Trenton, in the County of Mercer, elsewhere,  
and within the jurisdiction of this Court, purposely did attempt  
to obtain property of another by deception in an amount in excess  
of \$500; that is, the said ISHAK Y. BOUTROS, purposely did  
attempt to obtain property of The State of New Jersey Lottery  
Commission in excess of \$500 by creating or reinforcing the false  
impression that his Magnificent 7 lottery ticket number 732-  
038234-007 was valid;

WHEREAS IN TRUTH and IN FACT, as the said ISHAK Y. BOUTROS  
well knew, his Magnificent 7 lottery ticket number 732-038234-007  
was not valid contrary to the provisions of N.J.S.A. 2C:20-4a and


N.J.S.A. 2C:5-1, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Forgery-Fourth Degree)

ISHAK Y. BOUTROS

between on or about December 3, 2007, and on or about December 4, 2007, at the City of Trenton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, with the purpose to defraud the State of New Jersey Lottery Commission, did utter a writing he knew to be altered or forged, that is, the said ISHAK Y. BOUTROS did utter to the State of New Jersey Lottery Commission an altered or forged Magnificent 7 lottery ticket number 732-038234-007, the said ISHAK Y. BOUTROS knowing the ticket to be altered or forged, contrary to the provisions of N.J.S.A. 2C:21-1a(3), and against the peace of this State, the government and dignity of the same.
