The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

LUIS ROSADO

on or about May 7, 2007, at the Borough of Middlesex, in the County of Middlesex, and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph(s), film(s), videotape(s), computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said LUIS ROSADO gave, provided,

delivered, transferred, distributed, circulated, disseminated, or presented over the Internet a photograph or video depicting a child engaging in a prohibited sexual act, contrary to the provisions of N.J.S.A. 2C:24-4b(5) (a), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

LUIS ROSADO

between on or about May 7, 2007 and September 26, 2007, at the Borough of Middlesex, in the County of Middlesex, and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph(s), film(s), videotape(s), computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said LUIS ROSADO offered or agreed to offer over the Internet a photograph or video depicting a child engaging in a prohibited sexual act, contrary to the provisions of N.J.S.A. 2C:24-4b(5) (a), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Endangering the Welfare of a Child)

(Possession of Child Pornography - Fourth Degree)

LUIS ROSADO

between on or about May 7, 2007 and September 26, 2007, at the Borough of Middlesex, in the County of Middlesex, and within the jurisdiction of this Court, did knowingly possess or knowingly view any photograph(s), film(s), videotape(s), computer program(s) or file(s) or any other reproduction or reconstruction depicting a child engaged in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), including on the Internet, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(b), and against the peace of this State, the government and dignity of the same.
