COUNT ONE

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

WILLIAM G. EVANS

on or about July 20, 2007, at the Township of Rockaway, in the County of Morris, elsewhere and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph, film, videotape, computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said WILLIAM G. EVANS provided an image depicting a child engaging in a prohibited sexual act to a Detective from the New Jersey State Police Digital Technology Investigations Unit over the Internet, contrary to the provisions

of N.J.S.A. 2C:24-4b(5) (a), and against the peace of this State,  
the government and dignity of the same.

COUNT TWO

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

WILLIAM G. EVANS

between on or about July 20, 2007 and on or about September 26, 2007, at the Township of Rockaway, in the County of Morris, elsewhere and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph, film, videotape, computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said WILLIAM G. EVANS offered or agreed to offer an image or video depicting a child engaging in a prohibited sexual act, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(a), and against the peace of this State, the government and dignity of the same.



(Possession of Child Pornography - Fourth Degree)


WILLIAM G. EVANS

between on or about July 20, 2007, and on or about September 26, 2007, at the Township of Rockaway, in the County of Morris, elsewhere and within the jurisdiction of this Court, did knowingly possess or knowingly view any photograph(s), computer program(s) or file(s) depicting children engaged in prohibited sexual acts or in the simulation of such acts as defined by N.J.S.A. 2C:24-4b(1), including on the Internet, and also contained on computer media, contrary to the provisions of N.J.S.A. 2C:24-4b(5) (b), and against the peace of this State, the government and dignity of the same.


