INDICTMENT

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Official Misconduct - Second Degree)

ELBERT REID

between on or about August 17, 2007, and on or about October 22, 2007, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did aid with the purpose of promoting or facilitating the offense or did commit the offense of official misconduct, when with the purpose to obtain a benefit for himself or another did commit an act relating to his office, but constituting an unauthorized exercise of his official functions, knowing that such act was unauthorized or that he was committing it in an unauthorized manner, that is, the said ELBERT REID, being a public servant, an Inspector of the New Jersey Motor Vehicle Commission (Parsons) which provides

motor vehicle services on behalf of the State of New Jersey, having thereby the official functions and duties, among others, to use all reasonable means to display good faith, honesty and integrity, to be impervious to corrupting influences and to refrain from soliciting or accepting from any person anything of value for the performance of his official functions, and acting with the purpose to obtain a benefit for himself, the said ELBERT REID, without authorization and in an unauthorized manner, did accept a bribe of \$100 from a Confidential Informant (CI), who was cooperating with the New Jersey State Police, for the improper issuance of a fraudulent automobile inspection sticker, number 1244721; and did also accept bribes of \$120 from Y.R., a New Jersey State Police Detective, who at all times was acting in an undercover capacity and whose identity is known to the Grand Jurors, for the improper issuance of two fraudulent automobile inspection stickers, numbers 1514691 and 1515279; contrary to the provisions of N.J.S.A. 2C:30-2 and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Forgery - Third Degree)

ELBERT REID

on or about August 23, 2007, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, with purpose to defraud or injure another, did utter a writing of another which he knew to be forged, that is, the said ELBERT REID, with purpose to defraud the New Jersey Motor Vehicle Commission, did utter an automobile inspection sticker, number 1244721, purportedly issued by the New Jersey Motor Vehicle Commission, when, in fact, the New Jersey Motor Vehicle Commission did not authorize that act, contrary to the provisions of N.J.S.A. 2C:21-1a3 and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of same.

COUNT THREE

(Forgery - Third Degree)



COUNT FOUR


