
ORDER OF VENUE

INDICTMENT

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Bribery in Official Matters and Political Matters
- Second Degree)

WON JUN HUR

between on or about July 1, 2008 and August 31, 2008, at the City of Clifton, in the County of Passaic, elsewhere, and within the jurisdiction of this Court, the said WON JUN HUR, knowingly did directly or indirectly offer, confer or agree to confer upon a Detective employed by the New Jersey Division of Criminal Justice, who at all times was acting in an undercover capacity, a benefit, that is, did confer a monetary payment in excess of \$200, as consideration for a violation of an official duty of a public servant by providing a false inspection report, contrary to the provisions of N.J.S.A. 2C:27-2c, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Offer of Unlawful Benefit to Public Servant for Official
Behavior - Second Degree)


WON JUN HUR

between on or about July 1, 2008 and on or about August 31, 2008,
at the City of Clifton, in the County of Passaic, elsewhere, and
within the jurisdiction of this Court, did offer, confer or agree
to confer benefits valued in excess of \$200, to influence a
public servant in the performance of an official duty or to
commit a violation of an official duty, that is, the said WON JUN
HUR did offer a monetary payment in excess of \$200 to a Detective
employed by the New Jersey Division of Criminal Justice, who at
all times was acting in an undercover capacity, to commit a
violation of an official duty by providing a false inspection
report, contrary to the provisions of N.J.S.A. 2C:27-11a, and
against the peace of this State, the government and dignity of
the same.
