1. Knowingly or purposely to distribute a controlled dangerous substance, that is, cocaine, in a quantity of one-half ounce or more including any adulterants or dilutants, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-5a(1) and <u>N.J.S.A.</u> 2C:35-5b(2).

 Knowingly to sell or dispose of a firearm without being licensed or registered to do so as provided in <u>N.J.S.A.</u>
2C:58-1, <u>et seq.</u>, contrary to the provisions of <u>N.J.S.A.</u>
2C:39-9d.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.


