COUNT ONE

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

STUART PATTERSON

on or about November 10, 2007, at the Township of Kearny in the County of Hudson, and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph, film, videotape, computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said STUART PATTERSON, did distribute email containing attachments depicting nude children for the purpose of sexual stimulation or gratification of the viewer, contrary to the

provisions of N.J.S.A. 2C:24-4b(5) (a), and against the peace of this State, the government and dignity of the same.

COUNT TWO



(Possession of Child Pornography - Fourth Degree)

STUART PATTERSON

between on or about November 10, 2007 and on or about October 10, 2008, at the Township of Kearny in the County of Hudson and at Borough of Keansburg in the County of Monmouth, elsewhere and within the jurisdiction of this Court, did knowingly possess or knowingly view any photograph(s), computer program(s) or file(s) depicting children engaged in prohibited sexual acts or in the simulation of such acts as defined by N.J.S.A. 2C:24-4b(1), including on the Internet, and also contained on computer media, contrary to the provisions of N.J.S.A. 2C:24-4b(5) (b), and against the peace of this State, the government and dignity of the same.


