 commit the offense of official misconduct, in that the said CARMINE CASCIANO, acting with purpose to obtain a benefit for himself or another or to injure or to deprive another of a benefit, did commit one or more acts relating to his office, but constituting an unauthorized exercise of his official functions, knowing that such acts were unauthorized or that he was committing them in an unauthorized manner, or did knowingly refrain from performing a duty imposed upon him by law or clearly inherent in the nature of his office, that is, the said CARMINE CASCIANO, then and there being a public servant, to wit: the Essex County Commissioner of Registration and Superintendent of Elections, having thereby the official functions and duties, among others, to oversee election operations and manage personnel, to perform his duties in a legal and proper manner, to display good faith, honesty, and integrity, to be impervious to corrupting influences, to ensure compliance with election laws and county time and attendance policies, and to maintain the integrity of the electoral process; did, with purpose to secure a benefit for himself or another or to injure or to deprive another of a benefit, (1) agree or allow employees of his office to be given paid days off to compensate them for vacation days used by the same employees to work on political campaigns, when, in fact, as he well knew, such actions were not authorized,
