#### COUNT ONE

(Conspiracy - Second Degree)

ANNE MARIE MANFREDONIA

2010, at the Borough of Lodi, in the County of Bergen, elsewhere, and within the jurisdiction of the Court, with the purpose of promoting and facilitating the commission of the crimes of official misconduct, bribery, computer theft, and tampering with public records or information, did agree together and with a member of the New Jersey Division of Criminal Justice working in an undercover capacity, that:

- A. One or more of them would engage in conduct which would constitute the aforesaid crimes; or
- B. One or more of them knowingly would aid in the planning, attempt, solicitation or commission of the said crimes, that is:
- 1. Knowingly commit an act relating to the office of a public servant but constituting an unauthorized exercise of said public servant's official functions, knowing that such act was unauthorized or was being committed in an unauthorized manner, or knowingly to refrain from performing a duty which is imposed upon said public servant by law or which is clearly inherent in the nature of the public office, with purpose to obtain a benefit for the public servant or another, contrary to the provisions of N.J.S.A. 2C:30-2.
- 2. Knowingly directly or indirectly offer, confer or agree to confer upon another, or solicit, accept or agree to accept from another, any benefit as consideration for a

violation of an official duty of a public servant, or any benefit as consideration for the performance of an official duty of a public servant, contrary to the provisions of N.J.S.A. 2C:27-2c and N.J.S.A. 2C:27-2d.

- 3. Purposely or knowingly, without authorization or in excess of authorization, alter the New Jersey Motor Vehicle Commission data base or other computer storage medium, contrary to the provisions of N.J.S.A. 2C:20-25.
- 4. With purpose to defraud the New Jersey Motor Vehicle Commission, make, present, offer for filing, or use any record, document or thing, knowing it to be false, and with purpose that it be taken as a genuine part of any record, document or thing belonging to, or received or kept by, the government for information or record, or required by law to be kept by others for information of the government, contrary to the provisions of N.J.S.A. 2C:28-7a(2).

The Grand Jurors aforesaid, upon their oaths, do further present that:

It was part of the said conspiracy that ANNE MARIE
MANFREDONIA, a Customer Service Representative for the New Jersey
Motor Vehicle Commission, did accept money in exchange for the
improper issuance of New Jersey Motor Vehicle Commission
identification documents, including driver's licenses.

It was part of the said conspiracy that HILDELBERTO SALINAS did recruit individuals who could not legitimately obtain New Jersey Motor Vehicle Commission identification documents, including driver's licenses, accept money from these individuals, and arrange for these individuals to obtain New Jersey Motor Vehicle Commission identification documents, including driver's licenses, from ANNE MARIE MANFREDONIA.

It was part of the said conspiracy that ABRAHAM CHALI,
MIGUEL G. SACOTO, MEVLAN LITA, (JUAN) PABLO GAVILANEZ, JOSE
PELAEZ, GUSTAVO POMAVILLA, ROBERTO YUMBLA, ANA ALTAMIRANO,
ARIOLFO ALTAMIRANO, LUZ ALVAREZ, OMAR AVILA, CLAUDIO ANGAMARCA,
AURELIO AJU-CHITIC, and SANDRA AVENDANO-MARIN, did give money to
HILDELBERTO SALINAS and ANNE MARIE MANFREDONIA in exchange for
the improper issuance of New Jersey Motor Vehicle Commission
identification documents, including driver's licenses.

All contrary to the provisions of  $\underline{\text{N.J.S.A.}}$  2C:5-2, and against the peace of this State, the government and dignity of the same.

(Pattern of Official Misconduct - Second Degree)

ANNE MARIE MANFREDONIA

between on or about May 29, 2009, and on or about December 15, 2010, at the Borough of Lodi, in the County of Bergen, elsewhere, and within the jurisdiction of this Court, did commit the offense of Pattern of Official Misconduct in that she did commit two or more acts of Official Misconduct, each in violation of N.J.S.A. 2C:30-2, that is, the said ANNE MARIE MANFREDONIA, then and there being a public servant, to wit: a Customer Service Representative with the New Jersey Motor Vehicle Commission, Lodi Agency, having thereby the official functions and duties, among others, to verify that individuals applying for New Jersey driver's licenses are thereby authorized to receive said licenses, to process and issue New Jersey Motor Vehicle Commission Digital driver's licenses, to perform her duties in a legal and proper manner, to display good faith, honesty and integrity, and to be impervious to corrupting influences, did commit two or more acts of Official Misconduct, at least one of which was a crime of the second degree, including but not limited to those acts described in Counts Three through Seventeen, which allegations are incorporated by reference as if fully set forth herein, contrary to the provisions of N.J.S.A. 2C:30-7, N.J.S.A. 2C:2-6, and

against the peace of this State, the government and dignity of the same.
