The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

THROUGH

COUNT SIXTY

(Health Care Claims Fraud - Second Degree)

Between on or about October 9, 2006, and August 13, 2009, in the City of Bayonne, in the County of Hudson, elsewhere, and within the jurisdiction of this Court,

CHARLES BOAS, D.C.

who is licensed in this State to practice chiropractic medicine, in the course of providing professional services, knowingly did commit health care claims fraud, that is, the said CHARLES BOAS did make or cause to be made false, fictitious, fraudulent, or misleading statements of material facts in, or knowingly did omit material facts from, or did cause material facts to be omitted from any

record, bill, claim or other document, in writing, electronically or in any other form, that he did attempt to submit, submit, cause to be submitted or attempt to cause to be submitted for payment or reimbursement for health care services;

THAT IS, the said CHARLES BOAS, D.C., in the course of providing professional services, did knowingly make false statements and submit false claims to Horizon Blue Cross Blue Shield stating that he provided chiropractic treatments and services to nine patients, whose full names and identities are known to the Grand Jurors, and did not provide chiropractic treatments and services to the patients on the dates of service that were provided in the claims submitted to Horizon Blue Cross Blue Shield. The initials of the patients who were the subject of false statements, the specific claims identified by claim number, and the time periods that are the subject of the specific claim numbers are listed below:

(Theft by Deception - Third Degree)

Between on or about October 9, 2006, and August 13, 2009, in the City of Bayonne, in the County of Hudson, elsewhere, and within the jurisdiction of this Court,

CHARLES BOAS, D.C.


did purposely obtain the property of another by deception in excess of \$500, that is the said CHARLES BOAS, D.C., did purposely obtain property in the approximate amount of \$13,626.06 from Horizon Blue Cross Blue Shield by creating or reinforcing the false impression that the said CHARLES BOAS, D.C., was entitled to payment for chiropractic treatments and services provided to certain patients, whose names and identities are known to the Grand Jurors;

WHEREAS, IN TRUTH AND IN FACT, as the said CHARLES BOAS, D.C., well knew, he submitted claims to Horizon Blue Cross Blue Shield for providing chiropractic services and treatments which were not provided, and was therefore not entitled to payment from Horizon Blue Cross Blue Shield, contrary to the provisions of N.J.S.A. 2C:20-4, and against the peace of this State, the government and dignity of the same.
