## BY THE DIRECTOR:

By Order dated December 23, 2015 former Acting Director Jonathan A. Orsen extended the time for Loren Cardinalle to transfer her interest in licenses held by Highway Entertainment, LLC, and C Entertainment, LLC, to bona fide third parties. The date for this to occur was extended to March 1, 2016, April 1, 2016, June 1, 2016, September 15, 2016, January 2, 2017, March 31, 2017, June 2, 2017, July 28, 2017 and September 29, 2017. If the transfer did not occur by such respective date the licenses would be immediately suspended until the transfer occurred. A previous Consent Order from January 2011 initially required this occur by December 31, 2015.

The December 23, 2015 extension is connected to Ms. Cardinalle's request that the Division allow Ms. Cardinalle to maintain her interest in these licenses and not be required to divest her interest. As part of this request, Ms. Cardinalle's attorney, John P. Inglesino, Esq., prepared a submission as part of the request. I agreed to stay the requirement to transfer the license indefinitely so as to consider this request to modify the Consent Order.

I have considered Ms. Cardinalle's request, along with all supporting documents submitted on her behalf. I will not modify the terms of the Consent Order, including Paragraph 13, i.e., the requirement the licenses be sold/transferred to bona fide third parties or be indefinitely suspended until done so.

So as to allow for an orderly winding up of the licensee's operations, I will permit the licenses to operate until December 17, 2017 at 2:00 a.m. Thereafter, the licenses may continue to operate without live entertainment until January 3, 2018 at 2:00 a.m. At that time the licenses will be indefinitely suspended until sold/transferred to bona fide third parties. If the licensees do allow, permit or suffer live entertainment on the licensed premises after December 17, 2017, the licenses will be subject to the indefinite suspension immediately as well as potential disciplinary charges for violating this order.

THEREFORE, it is on this  $20^{25}$  day of November 2017,

ORDERED that the September 26, 2017 Order Extending Time to Sell/Transfer License is VACATED and;

IT IS FURTHER ORDERED Paragraph 13 of the January 13, 2011 Consent Order is amended and now will require that the transfer/sale of both licenses to a bona fide third party occur by January 3, 2018 at 2:00 a.m. In the event either license has not been sold/transferred to a bona fide third party by January 3, 2018, the license(s) shall be immediately suspended for an indefinite period until such sale/transfer is effectuated and;

IT IS FURTHER ORDERED that the licenses will be permitted to offer live entertainment at each licensed premise until December 17, 2017 at 2:00 a.m. Thereafter, the licenses may continue to operate without live entertainment until January 3, 2017 at 2:00 a.m., and;

IT IS FURTHER ORDERED that if either license allows, permits or suffers live entertainment after December 17, 2017 at 2:00 a.m. through January 3, 2018, the indefinite suspension shall be immediately imposed and would constitute a violation of this order subjecting the licensees to administrative discipline.
