



Purpose and Use of the Icon

This icon, developed by the New Jersey Attorney General, allows you to quickly report abusive behavior and sexually inappropriate materials to the operator of the social networking site. Site operators using the icon have agreed, among other things, to review all reports and alert law enforcement about possible predators or crimes.

Remember, however, that the *Report Abuse! Icon* is *not* a 911 line to the police. Call police immediately if, for any reason, you feel that you or someone else is in danger or has been threatened by someone on-line.

How it Works

The Report Abuse! Icon appears in a prominent and consistent location on each Web page of a social networking site that is using the icon and has agreed to follow the standards of service associated with it. The presence of the Report Abuse! Icon on each page will allow you to quickly report abusive behavior and sexually inappropriate materials to the operator of the social networking site.

- Once clicked, the Icon will take you to a Web page on which reports can be made and submitted on-line.
- Safety tips will be made available to you.
- You will have the opportunity to block the person suspected of committing abuse from having any further contact with you.
- You will have a set of standard categories to pick from including: child pornography, cyber-bullying or harassment, depictions of violence, predator alert, phishing/identity theft, sexually explicit material/nudity, suicide, threat of violence and under age user.
- You will get a confirmation that your report has been made and receive additional instructions depending on the type of complaint.
