



**NJ PINELANDS COMMISSION
COMBINED PUBLIC DEVELOPMENT APPLICATION &
COMPELLING PUBLIC NEED WAIVER OF STRICT COMPLIANCE
SAMPLE NOTICE LANGUAGE**

Instructions for Applicant:

- 1) Fill out the body of the attached notice with the relevant information regarding your application. Be sure to check the box next to each standard from which a Waiver is required. We recommend that you submit the draft notice to the Pinelands Commission for approval prior to having it mailed and published.
- 2) Address a copy of the public notice to each of the owners of real property within 200 feet in all directions of the property subject of the application, based upon the certified list provided to you by the municipal tax assessor. Each notice must be sent by **certified mail**.
 - **Exception** – If the proposed development will not be located on a specific parcel, including a proposed development located within a right-of-way or easement, then notification of property owners within 200 feet is not required.
- 3) The text of the notice shall be published for one day in the official newspaper of the municipality in which the property is located.
 - **Addition** - If the proposed development will not be located on a specific parcel, including a proposed development located within a right-of-way or easement, then the applicant must also publish the text of the notice in any official newspapers of the Pinelands Commission having general circulation in any municipality in which the proposed development is located.
- 4) To demonstrate that the notice requirements have been met, please provide the following to the Pinelands Commission:
 - A copy of the certified list of owners of real property within 200 feet in all directions of the property subject of the application, if required;
 - A copy of the notice sent to property owners and the certified mail receipts for each property owner notified, if required; and
 - A copy of the notice(s) published in the newspaper(s), including the name and date of the newspaper(s); or
 - An affidavit of publication from the newspaper(s).
