## Highlight

Municipal effective tax rates rose again for Pinelands municipalities, from 2.53 in 2016 to 2.58 in 2017. The average effective municipal tax rate for 2017 outside the Pinelands was 2.88 per 100, up from 2.84 in 2016.

**Description:** The effective tax rate is a ratio of taxes to property value (expressed in hundredths). The effective tax rate is the rate at which a municipality taxes the (equalized) assessed value of property, and is equal to the general property tax adjusted by the municipality's equalization ratio as calculated by the New Jersey Department of the Treasury, Division of Taxation.

**Unit of Analysis**: Average effective tax rate data is compiled at the municipal level and regionally aggregated to allow for inside/outside the Pinelands and state analysis.

**Findings**: The trend in statewide average municipal effective tax rate stayed flat for 2017. Across the state, the average municipal effective tax rate was 2.63 per \$100. This represents a negligible increase of 0.004 per \$100 of valuation. Non-Pinelands municipalities' average effective tax rates continue to be higher than tax rates inside the Pinelands. The rate increased by about 1% on average in the non-Pinelands region. The average effective municipal tax rate for 2017 outside the Pinelands was 2.88 per \$100, 2017 Effective Tax Rate 0.49 - 2 up from 2.84 in 2016. 2.0 - 33.0 - 4In the Pinelands region, municipal tax rates rose 4.0 - 5 by about 2% for 2017. 
Among the Pinelands municipalities, Mullica Township had the largest increase over the past year. The effective tax rate in the Township was up 12% to 3.00. Folsom Borough also saw a substantial percentage increase of about 10% for a rate of 2.14. Municipalities that saw the greatest decreases in the tax rate included Wrightstown Borough (down 9% to 2.35) and Washington Township (down 6% to 1.75). The highest effective tax rate in the Pinelands region was found again in Egg Harbor City with a rate of 4.55 per 100. Dennis Township with a rate of 1.56 retained the lowest effective tax rate.


