Assessment Class Proportions

Highlight

Only very small shifts of about 1% or less are seen in the proportions of the assessment classes for Pinelands municipalities compared to 2016. The Pinelands region had the greatest 1-year change in residential assessments, which increased by 0.3%. The commercial class had the largest change in the non-Pinelands region and in the State (-4% and -2%, respectively).

Description: Assessment class proportions are derived by finding the ratio of the equalized value of each class (residential, commercial, vacant, etc.) to the total property equalized value. This helps to measure the municipality's reliance on different types of land uses for tax revenues.

Unit of Analysis: Data for assessment class proportions are compiled at the municipal level and regionally aggregated to allow for inside/outside the Pinelands and statewide analysis.

Findings: As seen in Table 1, below, assessment class proportions for each region have not experienced major shifts since 2010. The percentages provided for the assessment classes may not total 100% due to assessment classes that are not tracked such as utility and road classes. Again for 2017, there were no major changes in the assessment class proportions in the Pinelands region. Vacant and commercial assessments saw small (0.1%) decreases and residential had a slight increase of 0.3%. In the Non-Pinelands, the commercial category decreased by just over 1% and the residential proportion increased by approximately the same 2017 Proportion of Taxes percentage. In the State totals, assessment From Non-Residential Uses class percentages went mostly unchanged from Less than 20% 2016 to 2017. Table 1, below shows assessment 20% - 35% 35% - 45% class proportions and change between 2010 and 2017. Greater than 45% Due to rounding, change of less than 1% may not appear in the table.

Of the individual municipalities with at least 10% of their land in the Pinelands Area, Berlin Township and Buena Vista Township saw their proportions in residential uses expand the most, by just over 1%. Wrightstown Borough lost just over 1% in the residential assessment class and Lakehurst Borough also lost nearly 1% in the residential assessment class. Egg Harbor City, Hammonton and Hamilton Township all had slight increases in proportion of the assessment in apartment classes.

In terms of commercial assessment, Wrightstown Borough had a 1% expansion and Little Egg Harbor Township had almost 1% more commercial, although that development would be located outside the Pinelands Area. Buena Vista Township had a decrease of 1% in commercial ratables. Egg Harbor Township had just under a 1% loss in the commercial assessment.

Table 2 below shows the percentage of assessment classes for all Pinelands region municipalities.
