PVSC ANNOUNCES FUSCALDO'S ELECTION AS HEAD OF STATEWIDE ORGANIZATION

Forrest swears in newly elected officers

NEWARK – Passaic Valley Sewerage Commission Executive Director, Wayne J. Forrest, announced that Thomas Fuscaldo has been reelected as President of the Governmental Purchasing Association of New Jersey (GPANJ). The installation was held last night in East Windsor and his term is for the upcoming year. The GPANJ Executive Board invited Forrest, who is the former Somerset County Prosecutor, to swear in each of the newly elected officers.

"On behalf of the Commissioners and staff of PVSC, we are thrilled that Mr. Fuscaldo was reelected President of the Governmental Purchasing Association of New Jersey. The organization has a nine point mission statement focusing on increasing professional standards, advocating for better laws regarding purchasing and assisting the overall operations of New Jersey Government.

With many expansions, and recent upgrading to secondary treatment, the facility has been striving, since its initial operation in 1924, to improve local water quality in accordance with federal and state water quality standards. Since the creation of PVSC's River Restoration Program in 1998, which is charged with preserving and protecting over 100 miles of area waterways, has removed over 8,000 tons of debris from the Newark Bay, the Passaic River and its tributaries, and sponsored over 650 individual clean ups along shorelines and in communities, along with educating over 150,000 students on how they can help protect the Passaic River and our environment.
