**Content Note**

This collection consists, primarily, of papers of Dr. William Sanford Van Emburgh (died ca. 1776-78) of New Barbadoes Township, Bergen County. Most of the items relate to the disposition of the estate of William's father, Dr. Johannes Van Emburgh, including several deeds and releases between heirs. Most of the items are oversized and many are fragmented.

12. Inventory of bonds left by Dr. William S. Van Emburch at the time of his death, [no place], ca. 1776-1778 [fragmented].
13. Draft of bond and assignment of bonds, mortgages and notes between Gilbert Van Emburch, executor of Dr. William Sanford Van Emburch, and John King, Awry King, Garrabrant Garrabrants, James Powleson and John Van Emburch, relatives of Dr. Van Emburch, [no place], 7 August 1781 [2 items].
