CBVI: Number of persons screened for visual problems by the Commission for the Blind and Visually Impaired. Cumulative per fiscal year.	Commission for the Blind and Visually Impaired (CBVI) Prevention of Blindness Program works to save sight and restore vision whenever medically possible. Services include: mobile eye examinations; vision screenings for preschool and school-age children; on-sit screening at institutions and in communities; special diabetic outreach program; and other specialized eye screening programs that target underserved populations (e.g., minorities, the elderly, migrant farm workers, etc.)	http://www.state.nj.us/humanservices/cbvi/home/index.html	
CBVI: Average number of total lesson hours per teacher per year.	CBVI provides its education services throughout the calendar year, thus eliminating some scheduling issues inherent in providing services only during the 10-month school year. Lessons are scheduled before or after school and at the student's home based upon individual student needs. Education services will be provided during the summer months. This will include both individual and group lessons in Braille, and computer and assistive technology training. Training locations can be at the school (if the facility is open), the student's home, the Commission's regional offices, and community locations such as libraries. The bi-weekly instructor's schedule was reorganized to allow for nine days in the field every two weeks. DDD: Move consumers from 100% State- funded, out-of-state facilities to in-state, Federally-matched community reidential placements.	Historically, consumers were placed out of state when necessary services and supports were not available in New Jersey. Under federal Medicaid regulations and New Jersey's Community Care Waiver, many of these facilities are not eligible for federal reimbursement of state expenditures. With the advent of expanded service options over the past decade, DDD is working with consumers to move them from out- of-state congregate care type facilities to in-state community residential placements, thus reducing the number of services funded entirely by state appropriations.		

community residential placements in order to comply with <i>Olmstead</i> requirements that services be provided in the least restrictive	In 1999, the U.S. Supreme Court's <i>Olmstead</i> decision held that the Americans with Disabilities Act required states to place consumers in the least restrictive setting appropriate for their care. Many states, including New Jersey, have subsequently been sued for violation of this decision. The continued movement of consumers from institutional facilities to community residential settings is necessary to comply with the civil rights of disabled persons and to settle the current lawsuit.	http://www.state.nj.us/humanservices/ddd/home/index.html
	The Community Care Waiver (CCW) allows New Jersey to claim federal reimbursement for individuals who qualify for institutional care, but who receive services in the community. Cooperation with the initial eligibility process, as well as annual redeterminations, is a prerequisite for receiving certain DDD services. The Work Participation Rate is calculated as a percentage of the overall NJ TANF caseload participating in eligible activities, minus allowable deferrals and exemptions. The federal government calculates the official rate annually after the state submits final caseload data and caseload credits are applied. DDD: Developmental Center census decrease.	The Division of Developmental Disabilities currently services approximately 2,500 individuals in seven developmental centers at a cost of over \$500 million per year, meaning that one-third of the Division's budget serves 5.9% of its caseload. The General Assistance (GA) WorkFirst NJ Program provides time limited cash benefit assistance to very low income single adults or couples without dependents. DFD: Performance level of child support collections paid above the level of the most recent federal fiscal year level. Note: This is a quarterly measure that is officially certified by the Federal Office of Child Support Enforcement.	The Child Support Enforcement (CSE) program is a federal and state effort to foster parental responsibility and promote family self-sufficiency by ensuring that both parents support their children financially and emotionally. CSE agencies locate non-custodial parents, establish paternity when necessary, and establish and enforce orders for support. The level of child support collections is one of five required performance measures reported annually to the Federal Office of Child Support Enforcement. DDS: Enrollment of clients with disabilities in NJ Personal Preference Program.	New Jersey's Personal Preference Program (PPP) is an alternative delivery method of the Medicaid State Plan Personal Care Assistance (PCA) benefit, in which individuals are able to hire a nonprofessional caregiver, including family members to provide personal care. Medicaid: FamilyCare child enrollment (Title XXI/CHIP). Beginning in 7/11 change reporting of some CHIPRA eligible children as a Medicaid expansion group from Medicaid.	NJ FamilyCare is a federal and state funded health insurance program created to help New Jersey's uninsured children and certain low-income parents and guardians to have affordable health coverage. Medicaid: Managed Care enrollment - % of eligible Medicaid participants enrolled in Managed Care.	New Jersey Medicaid has been moving Medicaid clients from a traditional fee-for-service health insurance program, in which healthcare providers bill Medicaid directly, into managed care. Under managed care, clients enroll in an HMO, which manages their healthcare and offers special services in addition to the benefits to which Medicaid clients are entitled.
