This letter is written in regard to your proposal to undertake Federal Highway Administration-funded replacement of the Route 130 bridge over Big Timber Creek, with associated reconstruction of stormwater drainage and utility line infrastructure. This project is located in the Borough of Brooklawn in Camden County, and the Borough Westville in Gloucester County, New Jersey, between Route 130 Mile Posts 25.33 and 25.62. Based upon our review of the information that has been provided, it has been determined that the proposed work is authorized by Department of the Army Nationwide Permit (NWP) #23 Approved Categorical Exclusions pursuant to Section 10 of the Rivers and Harbors Act of 1899 (33 USC 403) and Section 404 of the Clean Water Act (33 USC 1344).

This verification of authorization under NWP #23 Approved Categorical Exclusions, described in the Federal Register at 86 FR 2744, is based on your agreement to comply with the general conditions, regional conditions and project specific special conditions listed in this letter. Federal permits require a concurrence from the State that the activity is consistent with the State's coastal zone management (CZM) program if the activity is located within or affects the State's coastal zone. Because the State of New Jersey has denied general CZM consistency concurrence for all the 2021 NWPs, an individual CZM consistency concurrence would be required. The required individual CZM consistency concurrence has been issued by the NJDEP. Therefore, no further action is required related to a CZM consistency concurrence for this verification.

Federal permits also require the State's certification of compliance with Section 401 of the Clean Water Act through the receipt of a 401 Water Quality Certification (WQC) if the activity involves a Section 404 discharge. Because the NJDEP has denied general WQC for all 2021 NWPs, an individual WQC would be required. The required individual WQC has been issued by the NJDEP. Therefore, no further action is required related to a WQC for this verification.

This verification of NWP authorization is valid until the 2021 Nationwide Permits expire on **March 15, 2026**, unless the NWP authorization is modified, suspended, or revoked prior to this date. In the event that the NWP authorization is modified during that time period, this expiration date will remain valid, provided the activity complies with any subsequent modification of the NWP authorization.

Activities which have commenced (i.e. are under construction) or are under contract to commence in reliance upon an NWP will remain authorized provided the activity is completed within twelve months of the date of an NWP's expiration, modification, or revocation, unless discretionary authority has been exercised on a case-by-case basis to modify, suspend, or revoke the authorization in accordance with 33 CFR 330.4(e) and 33 CFR 330.5 (c) or (d). Activities completed under the authorization of an NWP which was in effect at the time the activity was completed continue to be authorized by that NWP.

Special Conditions:

- 1. All work performed in association with the subject project shall be conducted in accordance with the **enclosed** project plans identified as "USACE Permit Plans, Route 130 Bridge Over Big Timber Creek, Contract No. 025144260", Sheets 1 through 9, prepared by McCormick Taylor, and dated January 2022.
- 2. Construction activities shall not result in the permanent disturbance or alteration of greater than 0.237 acres of Waters of the United States. Additionally, temporary construction activities shall not disturb or alter greater than 0.403 acres of Waters of the United States.

- 3. Any deviation in construction methodology or project design from that shown on the enclosed project plans must be approved by this office, in writing, prior to performance of the work. All modifications to the enclosed project plans shall be approved, in writing, by this office. No work shall be performed prior to written approval of this office.
- 4. This office shall be notified prior to the commencement of authorized work by completing and signing the **enclosed** "Notification of Commencement" form. This office shall also be notified within 10 days of the completion of the authorized work by completing and signing the **enclosed** "Notification of Completion" form. Notification is required each time maintenance work is to be done under the terms of this Corps of Engineers permit.
- 5. The permittee understands and agrees that, if future operations by the United States require the removal, relocation, or other alteration, of the structure or work herein authorized, or if, in the opinion of the Secretary of the Army or his authorized representative, said structure or work shall cause unreasonable obstruction to the free navigation of the navigable waters, the permittee will be required, upon due notice from the Corps of Engineers, to remove, relocate, or alter the structural work or obstructions caused thereby, without expense to the United States. No claim shall be made against the United States on account of any such removal or alteration.
- 6. You must allow representatives from this office to inspect the authorized activity at any time deemed necessary to ensure that it is being or has been accomplished in accordance with the terms and conditions of your general permit.
- 7. Any conditions in your State authorization required for compliance with the State CZM program and 401 WQC are conditions of this authorization by reference.
- 8. In accordance with Regional General Condition G-5 of the 2021 Nationwide Regional Permit Conditions for the State of New Jersey, to protect Essential Fish Habitat, specifically potential effects to spawning and diadromous fish migrations, in-water work shall **NOT** be conducted between **01 March and 30 June** of any calendar year. Work within cofferdams that fully enclose and dewater the project area can proceed any time during the year provided that the cofferdams are installed or removed outside of the seasonal work restriction and do not preclude the free movement of migrating and spawning aquatic species to ensure compliance with NWP General Conditions 2 and 3.

Also **enclosed** with this NWP verification letter is a form seeking any comments, positive or otherwise, on the procedures, timeliness, fairness, etc. of the permit process. You may forward your comments along with the signed "Notification of Commencement" form or "Notification of Completion" form, following the directions provided on the form.
