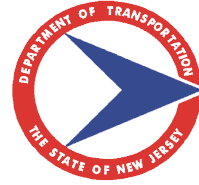

SUBJECT: Revision to the State Attachment No. 1 of the 2007 Standard Input.

The State Attachment No. 1 entitled "State of New Jersey Equal Employment Opportunity for Contracts Funded by Wholly State Funds" dated January 2007 Interim Revision March 2009 has been revised to incorporate mandated contract language per State Executive Order No. 151, non-discrimination contract language per N.J.A.C. 17:27 and State Treasury EEO/AA requirements. Additionally, the language contained in State Attachment No. 4 entitled "Equal Employment Opportunity Special Provisions Construction Contracts Funded by Wholly State Funds" dated January 2007 has now been merged in the revised Attachment No. 1. The Attachment No. 4 is hereby deleted. Consequently, Attachment No. 5 has been renumbered to State Attachment No. 4.

The title of Attachment No. 1 has also been revised in accordance with the State Treasury EEO/AA requirements.
