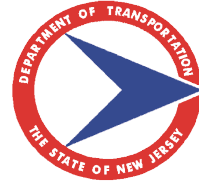

SUBJECT: Revision to the 2007 Standard Input regarding FHWA and State Attachments to the Special Provisions.

The Standard Input (SI 2007) has been revised to state that the FHWA Attachments and the Wholly State funded Attachments are now included after Division 1000 of the Standard Input, and will therefore be included in the Special Provisions.

Designers shall include additional Project Specific Attachments such as Asbestos Abatement, etc. The designers must continue to contact appropriate units and the SMEs as described in the instructions provided. Also, the Capital Project Procedures, Activity 3150 (Specification Development) Designers Units tasks have been revised accordingly.

The following revisions have been incorporated in Standard Input, SI2007 as of May 18, 2009.

SPECIFICATIONS TO BE USED

The 2007 Standard Specifications for Road and Bridge Construction, of the New Jersey Department of Transportation as amended herein will govern the construction of this Project and the execution of the Contract.

Pay the prevailing wage rates determined by the United States Secretary of Labor and the New Jersey Department of Labor. If the prevailing wage rate prescribed for any craft by the United States Secretary of Labor is not the same as the prevailing wage rate prescribed for that craft by the New Jersey Department of Labor, pay the higher rate.
