Subject: Standard Drawings for Overhead and Cantilever Sign Support Structures

Reference: Refer to BDC02D-04, dated July 24, 2002 for related information

The plates showing Standard Drawings for Overhead and Cantilever Sign Support Structures are hereby removed from the *NJDOT Design Manual for Bridges and Structures – Third Edition, 1998*. The Standard Drawings for Overhead and Cantilever Sign Support Structures will be issued as a separate detail package entitled, *General Design Criteria and Standard Drawings for Overhead and Cantilever Sign Support Structures, 2002*, as BDC02D-03 in U.S. Customary English units and as BDC02D-04 in metric units.

To incorporate these changes to the *NJDOT Design Manual for Bridges and Structures – Third Edition, 1998*, remove the following pages:

Remove **Plates 2.8-1 through 2.11-8**

Notice that Plate 2.8-1 is printed on the backside of Plate 2.7-4. In order to avoid unnecessary editing, the owners are advised to cross out Plate 2.8-1 and state “DELETED BY BDC02MB-01”, since Plate 2.7-4 will remain in the *NJDOT Design Manual for Bridges and Structures – Third Edition, 1998*.

This BDC Announcement hereby supersedes BDC01MB-1 (dated June 7, 2001) and BDC01MB-2 (dated June 8, 2001).

Instructions to Designers and Fabricators

The *General Design Criteria and Standard Drawings for Overhead and Cantilever Sign Support Structures, 2002*, shall be used for the design and fabrication of sign support structures and subsequent review of respective Shop Drawings.
