Subject: Revisions to Procedures Manual, Section 4.3, for the Engineer's Estimate and Proposal

Reference: Refer to [BDC02T-02](#), dated April 05, 2002 for related information

The procedures for preparing final engineer's construction cost estimate has been revised to use the new publication entitled *Construction Cost Estimation Preparation Manual for Final Engineer's Estimates* that was issued by BDC02T-02, dated 4/5/02. Therefore, the existing Subsection 4.3.3 Engineer's Estimate and Proposal, of the Procedures Manual has been renamed and revised to reference the use of the new manual for developing the final engineer's construction cost estimate for all Department projects.

The revision to existing Subsection 4.3.3.1 affects pages 4.3-20 through 4.3-23 and 4.3-33. All the revisions to this Subsection are included on page 4.3-20 as one paragraph. In order to avoid unnecessary editing that would result in issuing pages not related to the subject, current pages 4.3-21, 4.3-22 and 4.3-33, as well as the first four lines of page 4.3-23 are hereby **DELETED**. The owners are advised to delete existing pages 4.3-20, 4.3-22 and 4.3-33, as well as the first four lines of page 4.3-23 in their copy of the manual. It is suggested to cross out all text with an "X" and state "DELETED BY BDC02PR-01" on each deletion.

To incorporate these changes to the NJDOT Procedures Manual do the following:

Replace existing page **4.3-20** with the new page **4.3-20** and delete existing pages 4.3-21, 4.3-22, and 4.3-33, as well as the first four lines of page 4.3-23.

Instructions to Designers:

This BDC is one of two BDC's for developing final engineer's construction cost estimate. The other BDC02T-02 (dated 4/4/02) is for the construction cost estimation preparation manual for final engineer's estimates.

The requirements of both BDCs shall be followed by designers to develop final engineer's construction cost estimate for projects that are designed using either the Department's 2001 Metric or English units Standard Specifications for Road and Bridge Construction.
