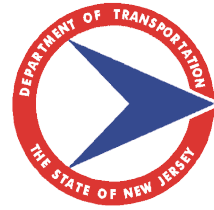

SUBJECT: Revisions to Subsection 105.15 of the 2001 Standard Inputs and Subsection 106.06 of the 2001 Standard Specifications in English and Metric units

Subsection 105.15 (Field Office) as contained in the 2001 Standard Inputs (SI2001E1 and SI2001M1) has been revised to provide hands-free headset device for cellular phones. Similarly, Subsection 106.06 (Materials Field Laboratory) has also been revised to provide hands-free headset device for cellular phones.
