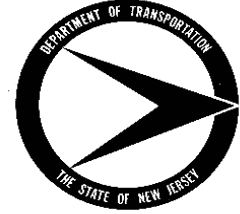

Baseline Document Change Announcement

Revisions to Standard Roadway Construction/Traffic Control/Bridge Construction Details dated October, 1996 BDC98D-001

February, 12, 1999

Subject: Changes and Additions to the Standard Roadway Construction Details, CD-602-1 and CD-616-1

Detail Sheets CD-602-1 and 616-1 *Standard Roadway Construction Details* have been revised to provide consistency with the *NJDOT Design Manual - Roadway*, "Section 10, Drainage Design". The following changes and additions were made to the *Standard Roadway Construction Details*:

- a concrete cutoff wall for end sections for metal pipe (CD-602-1.1)
- a concrete cutoff wall for end sections for concrete pipe (CD-602-1.2)
- a new detail for a concrete collar (CD-602-1.3)
- a new detail for stormwater outfall protection (CD-602-1.4)
- a pipe and inlet included in Section A-A (CD-616-1.2)

Instructions to Designers

Where applicable to a project, a copy of Standard Roadway Construction Detail CD-602-1 and 616-1 must be provided in the contract plans.
