SUBJECT: Design Manual-Roadway-Subsection 14-06-Traffic Stripes and Traffic Markings in Metric and English units - BDC04MR-01

REFERENCE: Revisions to the 2001 Standard Specifications Sections 618.03, 618.04, 618.05, 618.07, 618.08, 618.10, 618.15, 912.10 & 912.17 and the 2001 Standard Inputs 618.10, 912.12 in English and Metric units-BDC04S-03 dated October 19, 2004

Subsection 14-06 of the Roadway Design Manual is revised to include the use of Preformed Tape material on the roadways with Average Daily Traffic (ADT) as shown in Table "A", Page 14-6 . In addition, liquid system material has been introduced as an alternate striping material on non-interstate roadways.

14-6	Table A is added, Subparts 2 and 3 are revised (English Unit Design Manual).
14-6	Subparts 1, 2, 3 are revised and Table A is added. (Metric Unit Design Manual).

Although pages 14-7 through 14-14 (English Unit Design Manual) and pages 14-7 through 14-15 (Metric Unit Design Manual) have not been changed, they have to be re-issued due to shifting of the unchanged text.

These revisions must be reviewed in conjunction with the referenced revisions to the 2001 Standard Specifications (BDC04S-03) dated October 19, 2004.

This will allow designers to make necessary plan, specifications, and estimate/proposal changes without requiring the need for an addenda or postponement of advertisement or receipt of bids.
