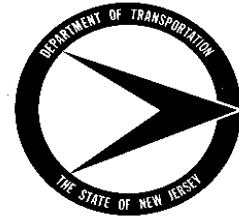

Baseline Document Change Announcement

Changes to Section 17 of the NJDOT Procedures Manual BDC98PR-007

March 12, 1999

Subject: Additions and Revisions to Section 17 of the NJDOT Procedures Manual

Additions and revisions to Section 17 of the *NJDOT Procedures Manual* have been made to provide consistency with the policy guidelines that are stated in the recently issued *1998 Bridges and Structures Design Manual* and criteria that is in Division 500 of the 1998 Supplemental Specifications. The revisions to Section 17 are as follows:

Replace	Pages 17.7-1 through 17.7-6	with	17.7-1 through 17.7-6
Replace	Pages 17.8-1 through 17.8-4	with	17.8-1 through 17.8-4
Replace	Pages 17.9-1 through 17.9-16	with	17.9-1 through 17.9-19

A summary of the revisions is as follows:

1. **Page 17.3-1** Design Appraisal Statement requirements clarified.
2. **Pages 17.3-2 & 17.3-3** Requirements for a Seismic Retrofit Report and Hydraulic and Scour Report added. Also, the process for the review and approval of scour countermeasures, for In-house and Consultant designed projects, is clarified.
3. **Page 17.4-12** Plan Sheet, for alternate proprietary walls, now referred to as Control Plan Sheet.
4. **Page 17.5-1** Direction for obtaining design and installation criteria for Variable Message Sign(VMS) structures stated. Also added an item to sections (2) and (3).
5. **Pages 17.7-2 through 17.7-6** Use of concrete overlay terminology, in lieu of the exclusive use of LMC, stated. Also, references to Standard Specification Subsections updated.
6. **Page 17.8-1** Editorial change to the method for obtaining a Water Quality Certificate from NJDEP clarified.
7. **Page 17.8-3** Address change for the First Coast Guard District provided.

8. **Page 17.9-1** Directions for submitting Working Drawings Procedure Memorandum have been revised in Items 1 and 2.
9. **Page 17.9-2** Changed references from Design Coordination to Geometric Design.
10. **Page 17.9-3** Added Item 10 which references Attachment 5 for sample illustration of Title Block Formats.
11. **Page 17.9-5** Information For Working Drawings Form. Added Federal Project # and D.P.#. Added note indicating that this form should be completed by the Project Manager at the Pre-Construction meeting.
12. **Page 17.9-7** Memorandum form provided for Working Drawing processing. Added note indicating that this form is to be completed at the time of award. Added Date of Award, Contract #, and Section #.
13. **Page 17.9-9** Replaced reference to “1989 Standard Specifications” with “current Standard Specifications”.
14. **Page 17.9-10** Added Item 6 to provide information regarding requests for approval of pile driving hammers.
15. **Page 17.9-11** Reference Subsection 17.9 of the NJDOT’s Procedure Manual rather than “at the
& **17.9-16** beginning of this Subsection”, has been added.
16. **Page 17.9-14** Letter to Contractor (In-House Designed Project). Replaced reference to “1989 Standard Specifications” with “current Standard Specifications”, added UPC#, and changed reference from Design Coordination to Geometric Design.
17. **Page 17.9-15** Added Item 5 to provide information regarding requests for approval of pile driving hammers.
18. **Pages 17.9-17** Samples provided, in metric units, to illustrate title block format and drawing
through 17.9-19 size limitations.

The pages containing revised text and those subsequent pages which have been affected by the revisions have been issued. In some instances a change on one page may have necessitated issuance of several additional following pages.

These additions and revisions to the *NJDOT Procedures Manual*, Section 17, are issued for immediate use in projects currently under Design and Construction.
