SYNOPSIS

Limits State ABP contributions for higher education faculty whose salary exceeds statutory maximum salary of Executive Branch department heads.

1 AN ACT concerning the State's pension contributions to the
2 Alternate Benefit Program and amending P.L.1969, c.242.

4 **BE IT ENACTED** by the Senate and General Assembly of the State
5 of New Jersey:

7 1. Section 8 of P.L.1969, c.242 (C.18A:66-174) is amended to
8 read as follows:

9 8. (a) The University of Medicine and Dentistry of New Jersey,
10 Rutgers, The State University and the New Jersey Institute of
11 Technology shall reduce the compensation of each participant in the
12 alternate benefit program and pay over to the insurers or mutual
13 fund companies for the benefit of the participant an employee
14 contribution for the retirement annuity contract or contracts equal to
15 5% of the participant's base salary. The intervals for deductions or
16 reductions and payments shall be determined by the respective
17 school governing bodies.

18 The Division of Pensions shall provide for reductions from the
19 compensation of each participant in the alternate benefit program
20 employed by the State and county colleges of an employee
21 contribution equal to 5% of the participant's base salary and pay this
22 amount to the insurers or mutual fund companies for the
23 individual's retirement annuity contract or contracts. The intervals
24 for deductions or reductions and payments shall be determined by
25 the Division of Pensions.

26 The Division of Pensions may require that all participant
27 contributions be made in accordance with section 414(h) of the
28 federal Internal Revenue Code (26 U.S.C. s.414(h)).

29 (b) Based on a certification to the Division of Pensions by the
30 University of Medicine and Dentistry of New Jersey, Rutgers, The
31 State University and the New Jersey Institute of Technology of the
32 number and base salary of participants, the division shall authorize

1 the State to make payment of the employer contributions to the
2 alternate benefit program at a rate equal to 8% of the employee's
3 base salary, except the amount of the contribution shall not exceed
4 8% of the maximum salary for department officers established
5 pursuant to section 1 of (P.L.1974, c.55 (C.52:14-15.107)), which
6 moneys shall be paid to the designated insurers or mutual fund
7 companies for the benefit of each participant.

8 Based on a certification by the Division of Pensions of the
9 number and base salary of participants employed by the State and
10 county colleges, the State shall make payment of the employer
11 contributions to the alternate benefit program at a rate equal to 8%
12 of the employee's base salary, except the amount of the contribution
13 shall not exceed 8% of the maximum salary for department officers
14 established pursuant to section 1 of (P.L.1974, c.55 (C.52:14-
15 15.107)), which moneys shall be paid to the designated insurers or
16 mutual fund companies for the benefit of each participant.

17 (c) For the member of the Public Employees' Retirement System
18 employed by the county colleges, who is defined in the regulations
19 of the Division of Pensions as a full-time faculty member and who
20 is permitted to transfer his membership and does so, the State shall
21 pay the employer contribution to the alternate benefit program at a
22 rate equal to 8% of the member's base salary, except the amount of
23 the contribution shall not exceed 8% of the maximum salary for
24 department officers established pursuant to section 1 of (P.L.1974,
25 c.55 (C.52:14-15.107)). If the member continues membership in the
26 Public Employees' Retirement System, the State shall pay the
27 employer contribution to the retirement system on his behalf and
28 such employer contribution shall be at a rate equal to the normal
29 contribution made by the State on behalf of nonveteran members of
30 the Public Employees' Retirement System.

31 (d) For any nonacademic employee of a county college, as
32 defined in section 4 of P.L.1969, c.242 (C.18A:66-170), who is
33 eligible for the program according to the regulations of the Director
34 of the Division of Pensions, the county college shall pay the
