This is a six (6) month term contract with four (4), three (3) month extension options. Prices are to remain firm for the original contract period and any extensions thereof.

THIS CONTRACT IS FOR 30% RECYCLED PAPER ONLY.

Bid proposals indicating cartons of bond/copy paper having less than 5,000 sheets (junior cartons, 8 ½ x 11") will be rejected. ALL PAPER IS 20 LB. BOND recycled.

Line 34.....1 part – 14 7/8 x 8 1/2” white, green bar, recycled, 20 lb. Order will be from 1 to 51 cartons for which the Using Agency will pay the carton price.

SPECIAL NOTES –

Using Agencies may issue blanket orders for automatic pre arranged shipment.

The minimum ordering quantities will be as indicated on the pricing sheets. Typical shipments will vary by Using Agency, but will not be less than a basic unit pack.

Deliveries to prisons or institutions will be necessary and may require additional delivery time due to security procedures. Contractors must follow such security arrangements as may be required by the requesting agency.

Contractors must have a heated distribution warehouse in New Jersey capable of covering the entire State on a regular delivery schedule. It must have a fleet of trucks already in use which are covering the State.

Sufficient advance notice to the State must be made by the Mill and Contractor in the event there is an increase in paper prices or a problem with deliveries.

DELIVERY REQUIREMENTS

Deliveries to all State Using Agencies must be made within three (3) working days after order is placed by phone or fax unless otherwise agreed. The contractor shall provide, for each delivery, a receipt showing the items being delivered and the Using Agency purchase order number. When a contractor delivers to such a Using agency, it shall obtain proof of delivery signed by an authorized employee of the receiving unit, location or Agency. This proof of delivery must accompany the contractor's invoice when submitted for payment.

Prices submitted are net, FOB Destination, and shall include, where specified, platform (dock) delivery and inside delivery, including elevator use for delivery to the designated delivery location when Using Agencies do not have dock facilities.

All prices submitted are to be FOB destination, State of New Jersey.

STANDARD PACKAGING.

All paper must be boxed in a moisture proof paper with the printed label attached indicating the mill brand, type of paper, size, substance weight, grain and number of sheets contained therein.

Cut reams are to be packed in junior cartons containing not more than ten (10) reams each.

All cartons must be plainly marked as to content before shipment.

The paper shall be full size, and cut square on all four (4) sides.

The grain direction for each product must be “industry standard”.

Paper having a curl that cannot be overcome under reasonable working conditions will be rejected.

A bill of lading describing the contents must accompany each shipment.

If latent defects should be discovered after the product has been accepted, the contractor shall be required to replace defective material at no cost to the State within 2 working days if required.

Photocopy and press paper must be capable of feeding error free in high speed equipment.

SPECIAL DELIVERY SITUATIONS

Trucking service must include delivery to and on the platform or doorway of the Using Agency. Deliveries may be to State Prison Facilities, county jails, mental health facilities, court office, legislative offices, and others where special care and security requirements will be encountered.

There are special delivery situations requiring extraordinary handling such as Vicinages, Courts, Senate and Assembly individual offices located throughout the State.

NOTE: The building at the John Fitch Plaza (Labor and Industry) will not accommodate tractor-trailer type trucks. There may be other locations currently being serviced by DSS that are not able to accommodate tractor-trailers.

SECURITY MEASURES

The contractor and its personnel shall be subject to and shall comply with all security regulations and procedures at each correctional facility. All contractor drivers and carrier drivers (including UPS and similar delivery services) will be subject to all security regulations and requirements at each individual correctional facility. This may include body and vehicle searches for contraband, as well as, prohibited items.

Maximum security facilities have the most stringent security requirements. Compliance with these requirements may require driver time and patience, but must be followed explicitly. Failure to deliver due to driver non-compliance with regard to required security measures at any correctional facility will be assessed as part of the contractor's performance review.

METHOD OF OPERATION

DELIVERY - All prices are F.O.B. Destination to platform, or inside to one location. Inside delivery may be required to one location above the first floor by use of an elevator. Contractors will be responsible for making their own delivery schedules which can be distributed to customers advising them as to when and how to place orders in time to meet their (contractors) predetermined delivery schedule.

The bidder's signature on the RFP certifies its ability to deliver to designated areas (except with special dispensation) within the State of New Jersey within three (3) working days after receipt of order.

Delivery service must include delivery to platform or front step of the Using Agency. Contractors may be required to provide inside delivery above the first floor.

MINIMUM ORDER - No minimum requirement.

FAULTY PRODUCT - Should the result of any test or inspection by authorized State representatives show that the product delivered fails to meet the requirements of the specifications, the material shall be rejected and immediately replaced by the contractor. Failure to replace unsatisfactory product may be cause for cancellation of contract and suspension from the State Bidder's List for future solicitations.

In the event that delivery is not made within the number of days stipulated, the Using Agency will be authorized to pick up the required material from the secondary contractor.

Requests for delivery, in many cases, will be made by telephone. In any case, all orders will be forwarded in hard copy to the contract vendor. The contractor is to be sure not to duplicate orders when the hard copy of an order (purchase order) is received.

Prices quoted shall be net, FOB any destination, prepaid within the State of New Jersey or region thereof, as indicated by the bidder.

PRIMARY CONTRACTOR – The primary contractor has the responsibility of completing each order for the items awarded within the prescribed delivery time.

SECONDARY CONTRACTOR - The secondary contractor will be used in the event the primary contractor, for any reason, cannot fill a requirement in the required time frame. Other reasons may inspire a Using Agency to use the Secondary Contractor, including but not limited to: color of bond paper selection, runability and texture.

FIXED PRICES - This contract does not allow Using Agencies to solicit competitive bids for the items included. All prices are fixed for the period of the contract.

Receipts: The Contractor shall provide for each delivery, a receipt showing the items being delivered.

Failure to provide accurate receipts for proof of delivery for all items will have a negative effect on the ability of using the Agency to pay invoices in a timely fashion. Those invoices submitted for payment without proper proof of delivery will be returned to the vendor until such proof is obtained.

CONTRACT TERM AND EXTENSION OPTION

The term of the contract shall be for a period of **SIX MONTHS**. The anticipated "Contract Effective Date" is provided on the cover sheet of this RFP. If delays in the procurement process result in a change to the anticipated Contract Effective Date, the bidder agrees to accept a contract for the full term of the contract. The contract may be extended for all or part of **four (4)**, six month periods, by the mutual written consent of the contractor and the Director. **Purchase orders may be placed against the contract up to and including the end of business on the last day of the contract, for delivery no more than 45 days after contract expiration.]**

CONTRACT TRANSITION

In the event that a new contract has not been awarded prior to the contract expiration date, as may be extended herein, it shall be incumbent upon the contractor to continue the contract under the same terms and conditions until a new contract can be completely operational. At no time shall this transition period extend more than 90 days beyond the expiration date of the contract.

AVAILABILITY OF FUNDS

The State's obligation to pay the contractor is contingent upon the availability of appropriated funds from which payment for contract purposes is made. No legal liability on the part of the State for payment of any money shall arise unless funds are made available each fiscal year to the Using Agency by the Legislature.

CONTRACT AMENDMENT

Any changes or modifications to the terms of the contract shall only be valid when they have been reduced to writing and signed by the contractor and the Director.

PROCEDURAL REQUIREMENTS AND AMENDMENTS

The contractor shall comply with procedural instructions that may be issued from time to time by the Director.

During the period of the contract, no contractual changes are permitted, unless approved in writing by the Director.

The State reserves the right to separately procure individual requirements that are the subject of the contract during the contract term, when deemed by the Director to be in the State's best interest.

ITEMS ORDERED AND DELIVERED

The State & Local Government Agencies are authorized to order and the Contractors are authorized to ship only those items covered by the contracts resulting from this RFP. If a review of orders placed by the Using Agency reveal that material other than that covered by the contract has been ordered and delivered, such delivery shall be a violation of the terms of the contract and may be considered by the Director in the termination of the contract or in the award of any subsequent contract. The Director may take such steps as are necessary to have the items returned by the Agency, regardless of the time between the date of delivery and discovery of the violation. In such event, the contractor shall reimburse the State the full purchase price.

The contract involves items which are necessary for the continuation of critical State services. Any delay in delivery of these items would disrupt State services and would force the State to immediately seek alternative sources of supply on an emergency basis. Timely delivery is critical to meeting the State's ongoing needs.

REMEDIES FOR NON-PERFORMANCE

In the event that the contractor fails to comply with any material contract requirements, the Director may take steps to terminate the contract in accordance with the State administrative code. In this event, the Director may authorize the delivery of contract items by any available means, with the difference between the price paid and the defaulting contractor's price either being deducted from any monies due the defaulting contractor or being an obligation owed the State by the defaulting contractor.

All products must conform in every respect to the standards and regulations established by Federal and New Jersey State laws.

All products shall be manufactured and packaged under modern sanitary conditions in accordance with good commercial practice.

All products are to be packaged in sizes as specified in this RFP and shall be packaged in such a manner as to insure delivery in first class condition and properly marked for identification. All shipments must be comprised of original cartons associated with the commercial industry represented by the actual product contained within each carton. Deliveries containing re-used, re-labeled, re-worked or alternate cartons are subject to rejection by the Using Agency at the contractor's expense.

CLAIMS AND REMEDIES

All claims asserted against the State by the contractor shall be subject to the New Jersey Tort Claims Act, N.J.S.A. 59:1-1, et seq., and/or the New Jersey Contractual Liability Act, N.J.S.A. 59:13-1, et seq.

Nothing in the contract shall be construed to be a waiver by the State of any warranty, expressed or implied, or any remedy at law or equity, except as specifically and expressly stated in writing executed by the Director.

PRIMARY & SECONDARY AWARDS - The State has made a primary and a secondary award for this contract. The secondary contract will be used in the event a primary contractor is unable to meet the delivery deadline when required or a price escalation makes the secondary award financially viable.

PAPER PRICE ESCALATION - Paper price increases may be considered by the Purchase Bureau after six months into the contract by providing documentation and proof that the increase exists and no other source of comparable paper is available. Contractor must provide proof of the impending increase at least 30 days in advance. Permission will be granted or denied by the Director. The Secondary Contractor may be considered at that time.
