



	Answer	<ol style="list-style-type: none"> The current contract expired and the using agency is acquiring these services through Direct Purchase Authority (DPA). Due to the changes in prevailing wage law stated in addendum #2 the previous contract pricing will not be applicable. Because these services are not currently acquired through a term contract the rates are not available.
