NJ Tax Due Date Calendar

Certain Companies engaged in "prohibited activities" in Business with the Governments of Russia or Belarus Disallowed from Receiving Tax Clearance

Governor Murphy signed Senate Bill 1889 (2R) into law on March 09, 2022, as P.L. 2022, Chapter 3, which takes effect immediately. The law requires the New Jersey Department of the Treasury to identify all businesses and individuals engaged in "prohibited activities in Russia or Belarus".

The Division will no longer issue tax clearance for any identified business or individual that engages in such activities. This law will expire if federal sanctions contained in the President's Executive Order 14024 expire.

Generally, a tax clearance means that a taxpayer's filings and payment obligation are in good standing.

Pass-Through, Business Alternative Income Tax (PTE-BAIT) Extended to June 15

Governor Murphy Proposes New

Property Tax Relief Program

Governor Phil Murphy unveiled a new initiative this month known as the ANCHOR Property Tax Relief Program, which expands and replaces the Homestead Rebate Program.

The ANCHOR (Affordable New Jersey Communities for Homeowners and Renters)
Property Tax Relief Program is part of the Governor's FY2023 Budget Proposal. The
ANCHOR Program will distribute \$900 million in property tax relief to nearly 1.8
million homeowners and renters across the state. Homeowners making up to \$250,000
per year would become eligible to receive an average \$700 rebate. Renters could be
eligible for a \$250 rebate.
