

West Deptford Township pair indicted on shoplifting charges

A pair of West Deptford Township residents has been

indicted by a Gloucester County Grand Jury on charges of shoplifting stemming from an incident in Monroe Township on May 6, 2014.

A man and a woman from West Deptford Township have been formally accused of shoplifting on May 6 in Monroe Township, according to the Gloucester County Prosecutor's Office.

Nicholas J. Viggiano, 33, and Marissa L. Finn, 26, both of West Deptford, have each been indicted on charges of shoplifting, conspiracy to commit shoplifting and resisting arrest.

- Markia M. Sutton, 19, of Williamstown, on robbery, burglary and theft charges in Monroe on Feb. 10.
- Amanda L. Jackman, 23, of Glassboro, on charges of possession of a controlled dangerous substance and resisting arrest on May 24 in the municipality.
- Lawrence Gonzalez, 55, and Clara E. Jordan, 26, both of the Bronx borough of New York City, on charges of possession of more than 2,000 unstamped cigarettes on Dec. 19, 2013, in Woolwich Township.
