Committee:	Constitution, Bylaws, and Program of Activities Committee

Purpose of Meeting:	To review and evaluate Constitution, Bylaws, and Program of Activities of the New Jersey FFA Association and make and suggestions necessary.
Recommended Action(s):	Since the actions to be taken in the Bylaws regarding chapters who have not met the requirements necessary to remained chartered with the NJ State FFA Association do not reflect currect policy, Ammend Bylaws Article I Section C by striking out "Grace Period" and inserting "Probation," and insert a following sentence stating, "a chapter placed on probation will not be able to participate in State/National events until the standards necessary for the chapter to remain chartered with the NJ State FFA Associatin are met. In response to the concerns of numerous advisors about State Officers, who have a high degree of training, competing in individual CDE's like Prepared Public Speaking, insert a Section J under Article III: State Officers, which reads, "Being that State Officers recieve a high degree of exclusive professional leadership and public speaking training, State Officers still enrolled in secondary education are not permitted to compete in individual Career Development Events."
Comments:	The last reccomendation was brought forth by Stuart Faunce on behalf of Mr. Dale Cruzan, Allentown FFA Advisor. While there were split viewpoints on this topic, the committee felt that it should be brought before the members for an offical resolution to be adopted.
