II. Minutes from December State Meeting

Motion by Kelsey Stockton to dispense with the reading of the meeting minutes and approve them as distributed.

Motion by Jeremy Posluszny to amend the minutes from the December State Meeting by striking out "January 17" and replacing it with "January 27" under State Officer Candidates' School.

Motion by Renee Stillwell to recommend amending the constitution by striking out, "concurrently reenrolled", and inserting "enrolled," in Article 3, Section A, Paragraph 4, and striking out, "in any way a Career Development Event which purpose or objective would give a State Officer leverage in any unfair way through officer training conducted by the Association itself," and inserting "as a contestant in the 6-8

Minute Public Speaking LDE, extemporaneous Public Speaking LDE, Employment Skills LDE, Official Ceremonies Event, Parliamentary Procedure LDE, Agricultural Issues LDE, Agricultural Sales CDE, or the Teach Agriculture Event" in Article 3, Section A, Paragraph 4.

Seconded by Morgan Rutar. Motion passes.

Motion by Kelsey Stockton to recommend amending the constitution by striking out "collegiate members and advisor", and inserting "Advisors" in article 5, Section B, Clause 3.

Seconded by Morgan Rutar. Motion passes.

Congress has made progress on drafting the 2018 Farm Bill. One challenge is keeping the same amount of funding that was provided through the 2014 Farm Bill because of the new tax cuts and decision to not increase funds overall. A few of the principles guiding the new farm

bill includes encouraging youth to enter farming through increased access to land and capital; strengthen the integrity and efficiency of the nutrition assistance programs; and prioritize investments in education, training and development of human capital to ensure that the nation's workforce can meet the growing demand for food and agriculture science.

Clarify State Officer CDE Participation (Article 3, Section A, Paragraph 4): -Strike out "concurrently reenrolled", and insert "enrolled," and -Strike out, "in any way a Career Development Event which purpose or objective would give a State Officer leverage in any unfair way through direct training conducted by the Association itself," and inserting "as a contestant in the 3-5 Minute Public Speaking LDE, 6-8 Minute Public Speaking LDE, Extemporaneous Public Speaking LDE, Employment Skills LDE, Official Ceremonies competition, Parliamentary Procedure LDE, Agricultural Issues LDE, Agricultural Sales CDE, or the Teach Ag CDE."
