There were nearly 700 entries in the Hort Expo and close to thirty industry individuals helped judge the event. It was a very successful and organized event.

B. National Ag. Day, Washington D.C.

On March 18, 2010 Keely, Brianne, and Jessica went to Washington D.C. to represent New Jersey and talked to representatives from Senator Lautenburg and Menedez office, and other congressman and assistants about FFA. We asked them to sign on to the National FFA coin commencement. The money collected from the coin will go toward agricultural education.
