### F. World Food Prize New Jersey Youth Institute Discussion

This is the first year the event is being held in New Jersey and will allow students to give oral presentations regarding current world food issues. # G. Agriculture Issues Discussion

New Jersey, realizing the deterioration of its water and air quality, is searching for alternative sources of power. Currently, New Jersey consumes 11.1 million gallons of gasoline per day, 4.1 million gallons of diesel fuel per day, and 3.3 million gallons of jet fuel per day. To combat this, New Jersey has turned to ethanol. However, the state does not grow enough corn and soybeans to meet demand, forcing the products to be imported and thus raising the cost. New Jersey officials have turned to farmers to help produce more biofuel for a cleaner, greener future.
