

**DIRECTIONS TO  
BURLINGTON COUNTY SPECIAL SERVICES  
WESTAMPTON CAMPUS**

**From Route 295 North or South:**

- Take Rt. 295 North or South to Exit 45A
- Follow the ramp onto Beverly Rancocas Road toward Mt. Holly.
- At the 2<sup>nd</sup> traffic light turn left onto Irick Road.
- Proceed on Irick Road to the first traffic light and turn right onto Woodlane Road.
- Proceed on Woodlane Road to the first traffic light and turn left onto Pioneer Blvd.
- Follow Pioneer Blvd. to the first right into the parking area, bear left to park.
- Enter through the door closes to the flagpole and sign in at the receptionist desk.

**From Route 130 Heading South:**

- Take Route 130 South to Burlington and turn left on Route 541 – East
- Follow past landmarks: Burlington Center Mall on left and NJ Turnpike Exit on right.
- Just after Charlie Brown’s Restaurant on left, bear right onto Woodlane Road.
- Proceed on Woodlane Road to the 2<sup>nd</sup> traffic light and turn right onto Pioneer Blvd.
- Follow Pioneer Blvd. to the first right into the parking area, bear left to park.
- Enter through the door closes to the flagpole and sign in at the receptionist desk.

**From Route 130 Heading North:**

- Take Route 130 North to Beverly Rancocas Road.
- Turn right onto Beverly Rancocas Road.
- Follow Beverly Rancocas Road toward Mt. Holly to Irick Road, turn left onto Irick Road.
- Proceed on Irick Road to the first traffic light and turn right onto Woodlane Road.
- Proceed on Woodlane Road to the first traffic light and turn left onto Pioneer Blvd.
- Follow Pioneer Blvd. to the first right into the parking area, bear left to park.
- Enter through the door closes to the flagpole and sign in at the receptionist desk.

**Heading North or South on NJ Turnpike:**

- Exit at Interchange 5.
- Proceed to traffic light and make right onto Rt. 541 East.
- Just after Charlie Brown’s Restaurant on left, bear right onto Woodlane Road.
- Proceed on Woodlane Road to the 2<sup>nd</sup> traffic light and turn right onto Pioneer Blvd.
- Follow Pioneer Blvd. to the first right into the parking area and bear left to park.
- Enter through the door closes to the flagpole and sign in at the receptionist desk.

**From Atlantic City and South East NJ:**

- Take Atlantic City Expressway to Exit 28 Hammonton.
- Proceed to Route 54 towards Hammonton.
- Continue on Route 54 to Route 206 North.
- Follow Route 206 North to Route 38 West.
- Proceed on Route 38 to Mount Holly Bypass and go to 2<sup>nd</sup> traffic light.
- Turn left onto Beverly Rancocas Road.
- Follow Beverly Rancocas Road to first traffic light and turn right onto Irick Road.
- Continue on Irick Road to the first traffic light and turn left onto Pioneer Blvd.
- Follow Pioneer Blvd. to the first right into the parking area and bear left to park.
- Enter through the door closes to the flagpole and sign in at the receptionist desk.
