	The required school lunch meal patterns for each grade group (K-5, 6-8, K-8, 9-12) are intended to result in age-appropriate and nutritious meals. Adaptions to the menus must be made to accommodate grades 6-8 and 9-12 within one school (e.g. grades 7-12). A suggestion is to start with the components that overlap, and make only minor adjustments to the vegetables or fruits components to increase calories for the older students.				
	On the day of review at lunch, all students, grades 7-12, had access to all the same components and menu items. There was no signage to distinguish the 7-8 graders were being served under the 6-8 meal pattern vs the 9-12 graders being served under the 9-12 meal pattern. The state agency and foodservice staff discussed posting signage and conducting a nutrient analysis to ensure the dietary specifications are in compliance for both grade groups (6-8 and 9-12).
