2019 Farm to School Census

The United States Department of Agriculture (USDA) Food and Nutrition Service (FNS) has contracted with Abt Associates Inc. to conduct the 2019 Farm to School Census (2019 Census). This Census will survey all public and private school food authorities (SFAs) that participate in the National School Lunch Program (NSLP) in all 50 States. Like the 2013 and 2015 Farm to School Censuses, the 2019 Census will gather information about the use of local foods in schools and other farm to school activities. NOTE: Even if a district did not conduct any Farm to School activities in SY2018-2019, their completion of the census is still important for the most accurate report of total Nationwide activity.

Data collection for the 2019 Census will begin in September 2019. SFA directors will be asked to complete one short web survey (sent to them via email) in order to provide information about local sourcing and farm to school activities. The Farm to School Census will be completed online and respondents can save progress and complete the survey later. The last day to report data is November 4.

If an SFA has lost the email with the link, that individual can email farmtoschool@abtassoc.com to have it re-sent to them. SFAs should also add that email address to their address books to assure that the recruitment emails will not go to their spam ("junk") folders. In addition to the above email address, respondents can call toll-free at 855-452-5794 (from 9 am to 9 pm ET) with any questions.

Frequently Asked Questions:

What is Farm to School?

Farm to school enriches the connection communities have with fresh, healthy food and local food producers by changing food purchasing and education practices at schools and early care and education sites. Farm to school empowers children and their families to make informed food choices while strengthening the local economy and contributing to vibrant communities.

Farm to school implementation differs by location but always includes one or more of the following three core elements:

- 1. Procurement: Local foods are purchased, promoted and served in the cafeteria, as a snack or in classroom taste-tests.
- **2.** Education: Students participate in education activities related to agriculture, food, health and nutrition.
- **3.** School gardens: Students engage in hands-on, experiential learning through gardening. To learn more about farm to school visit:

What information to have ready before completing the 2019 Census?

- The School Food Administrator (SFA)'s definition of local;
- The amount of money spent on local purchases;
- the most common products purchased locally;
- the sources of local products;
- benefits and challenges of participating in farm to school;
- the number and use of edible school gardens within the SFA; and,
- the number of salad bars within an SFA.
