DIVISION OF MARKETING AND DEVELOPMENT Notice of Readoption Commercial Feeding Stuffs

Readoption with Technical Changes: N.J.A.C. 2:68

Authority: N.J.S.A. 4:1-11.1 and 4:4-20.10.

Take notice that pursuant to N.J.S.A. 52:14B-5.1.c, the rules at N.J.A.C. 2:68 were scheduled to expire on September 28, 2023.

The readoption of N.J.A.C. 2:68 is necessary to continue to protect farmers and consumers by determining manufacturers' compliance with the guaranteed content of animal feed and to reduce the amount of misbranded and deficient products offered for sale, thereby, ensuring the quality of feed and protecting animal growth. The Department of Agriculture ("Department" of "NJDA") utilizes the standards set forth in the most updated edition of the Official Publication of the Association of American Feed Control Officials, Inc. (AAFCO). The AAFCO standards are recognized by the industry as the most comprehensive and current available. They are accepted throughout most of the United States. In addition to the regulation of feed terms, N.J.A.C. 2:68 also utilizes the official pet food regulations, the statement of uniform interpretation and policy, and lists of new animal drugs, certifiable antibiotics, and associated warning statements, the permitted analytical variations, and the pet food protocols and affidavits as published in the most updated edition of the Official Publication of the AAFCO. N.J.A.C. 2:68 also utilizes the official methods of analysis for feed and pet foods as published in the most updated edition of the Association of Official Analytical Chemists (AOAC), or in accordance with other official methods.

When N.J.A.C. 2:68 was last readopted in 2016, it referenced the 2015 edition of the Official Publication of the AAFCO, as amended and supplemented. Presently, the latest amended and supplemented edition of the Official Publication is the 2023 edition. As technical changes, this readoption changes references to the 2015 edition of the Official Publication, as amended and supplemented, to the 2023 edition of the Official Publication, as amended and supplemented.

Similarly, when N.J.A.C. 2:68 was last readopted, it referenced the 18th edition (2015) of the official methods of analysis published by AOAC, as amended and supplemented. Presently, the latest amended and supplemented edition of the official methods of analysis published by AOAC is the 21st edition (2019). As a technical change, the readoption of 2:68 changes references to the 18th edition (2015) of the official methods of analysis published by AOAC, as amended and supplemented, to the 21st edition (2019) of official methods of analysis published by AOAC, as amended and supplemented.

This readoption of N.J.A.C. 2:68 continues the Department's use of the most updated standards adopted by AAFCO and the most updated methods of analysis adopted by AOAC, through the incorporation by reference of ongoing revisions as adopted by AAFCO and AOAC.

Copies of the AAFCO publication and the AOAC publication are on file at the NJDA (NJDA), and each is available from the organization that publishes the document. Technical changes have been made to the contact information for the NJDA, AAFCO, and AOAC at N.JA.C. 2:68.

The Department has reviewed these rules and has determined that the rules should be readopted with technical changes. The rules are necessary, reasonable, and proper for the purpose for which they were originally promulgated. Therefore, pursuant to N.J.S.A. 52:14B-5.1.c(1), these rules are readopted and shall continue in effect for a seven-year period.

2:68-1.1 General rules and regulations

2:68-1.2 Uniform interpretation and policy

The Department of Agriculture adopts and incorporates by reference the uniform interpretation and policy as set forth in the [2015] **2023** edition of the [official publication] **Official Publication** of the Association of American Feed Control Officials, Inc., as amended and supplemented.

2:68-1.3 Glossary; official feed terms

The Department of Agriculture adopts and incorporates by reference the glossary of official feed terms as set forth in the [2015] **2023** edition of the Official Publication of the Association of American Feed Control Officials, Inc., as amended and supplemented.

2:68-1.4 Medicated feeds

The Department of Agriculture adopts and incorporates by reference the standards for medicated feeds as set forth in the [2015] **2023** edition of the [official publication] **Official Publication** of the Association of American Feed Control Officials, Inc., as amended and supplemented.

2:68-1.5 Definitions of feed ingredients

The Department of Agriculture adopts and incorporates by reference the definitions of feed ingredients are as set forth in the [2015] **2023** edition of the [official publication] **Official Publication** of the Association of American Feed Control Officials, Inc., as amended and supplemented.

2:68-1.6 Sampling and analysis

Sampling and analysis shall be conducted in accordance with methods published in the [18th] **21st** edition [(2015)] **(2019)** of the official methods of analysis of the Association of Official Analytical Chemists, which is incorporated herein by reference, as amended and supplemented, or in accordance with other recognized official methods.

2:68-1.7 Other rules and regulations

In addition to the definitions of feed ingredients and feed terms previously adopted, the Department of Agriculture adopts and incorporates by reference the official pet food regulations, the statement of uniform interpretation and policy, and lists of new animal drugs, certifiable antibiotics, and warning statements associated therewith, the permitted analytical variations and the pet food protocols and affidavits as contained in the [2015] **2023** edition of the [official publication] **Official Publication** of the Association of American Feed Control Officials, Inc., as amended and supplemented.

Take notice that pursuant to N.J.S.A. 52:14B-5.1.c, the rules at N.J.A.C. 2:69 were scheduled to expire on January 26, 2024.

The readoption of N.J.A.C. 2:69 protects farmers and consumers by determining the manufacturer's compliance with the guaranteed content of commercial fertilizers and soil conditioners; reduces the amount of misbranded and deficient products offered for sale, and thereby insures the quality and quantity of fertilizers and soil conditioners and promoting crop yield. Chapter 69 contains one subchapter that sets labeling and distribution standards, establishes the general methodology for sampling and laboratory analyses that help to promote uniformity in State fertilizer standards with respect to inspection techniques and adequate labeling, and provides a procedure by which the State Board of Agriculture annually determines the commercial values of primary plant nutrients.

The Department of Agriculture has reviewed these rules and has determined that the rules should be readopted without change. These rules are necessary, reasonable, and proper for the purpose for which they were originally promulgated. Therefore, pursuant to N.J.S.A. 52:14B-5.1.c(1), these rules are readopted and shall continue in effect for a seven-year period.

Notice of Readoption Aquaculture Development

Take notice that pursuant to N.J.S.A. 52:14B-5.1, the rules at N.J.A.C. 2:89 were scheduled to expire on October 26, 2023.

The rules establish an Aquatic Organism Health Management Plan designed to protect public and private aquaculturists and wild aquatic populations from the importation of non-endemic disease-causing organisms, and assist in facilitating the exportation and importation of aquatic species into and out of the State. It includes disease reporting and quarantine requirements as set forth at N.J.S.A. 4:5-1 et seq. These rules continue the established aquaculture policy framework that begun in 2004, to continue to foster the orderly development of aquaculture. This framework consists of an Aquatic Farmer License issued upon completion and approval of the Application for Aquatic Farmer License and acquisition of any additional permits that may be required by the New Jersey Department of Environmental Protection (NJDEP) or any other agency.

The Department of Agriculture has reviewed the rules and has determined that the rules should be readopted without substantal changes; however, technical changes are needed at N.J.A.C. 2:89-1.1(c) and 6.2 to correct statutory citation errors, and at N.J.A.C. 2:89-1.2, 2.4, and 5.1 to update agency or organization and publication names, to update a weblink, and to update certain contact details. The rules are necessary, reasonable, and proper for the purpose for which they were originally promulgated. Therefore, pursuant to N.J.S.A. 52:14B-5.1.c(1), these rules are readopted with technical changes and shall continue in effect for a seven-year period.

2:89-1.1 Purpose and scope

2:89-2.4 Aquaculture application

- (a) The application set forth [in] at Appendix A shall include the information set forth [in] at (a)1 through 4 below. The application set forth [in] at Appendix B shall include the information set forth [in] at (a)1 and 2 below.

- 4. Relevant permits: A list of all currently held and additional permits that are required by the NJDEP, [NJDHSS] **NJDOH**, or other appropriate agency. A preliminary assessment of required permits is provided in the application included at Appendix A.

SUBCHAPTER 5. AQUATIC ORGANISM HEALTH MANAGEMENT

2:89-5.1 Notice or existence of disease of concern

(a) Any veterinarian or other person (including, but not limited to, any auctioneer, broker[s], dealer, aquaculturist, extension agent, etc.) who shall gain knowledge of the existence or suspected existence of a reportable disease of finfish, mollusks, or crustaceans within the State, which is subject to an emergency declaration by USDA-APHIS or which is identified by the [Office des International Epizooties (OIE)] World Organization for Animal Health (WOAH), in the "[International] Aquatic Animal Health Code," which is adopted as amended and supplemented and incorporated herein by reference, must notify the Department without delay, but not more than 48 hours after gaining such knowledge.
