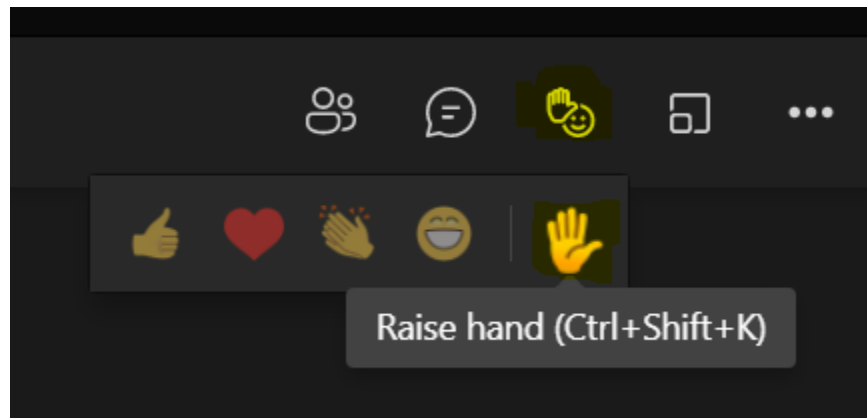


PLEASE BE ADVISED
