REQUIREMENTS:

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree to include or be supplemented by twelve (12) semester hour credits in one or a combination of the following: agricultural science, natural resource management, environmental science, environmental planning, or land use planning. Please upload a copy of your transcript with your application. Failure to do so will result in ineligibility.

EXPERIENCE: One (1) year of experience reviewing, developing, implementing, and maintaining agricultural, environmental, or land use management programs in the public or private sector.

NOTE: Applicants who have successfully completed the required courses or the required number of semester hour credits as specified above may substitute additional experience as indicated on a year-for-year basis for the remaining education with thirty (30) semester hour credits being equal to (1) year of experience.

NOTE: A Master's degree in Agricultural Science, Natural Resource Management, Environmental Science, Environmental Planning, Land Use Planning, or other related field may be substituted for the one (1) year of experience. If you are substituting a degree for the required experience, please upload a copy of your transcript with your application. Failure to do so will result in ineligibility.

Foreign transcripts must be evaluated by a recognized evaluation service. Please upload a copy of your evaluation with your application. Failure to do so will result in ineligibility.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

The responsibility for ensuring that employees possess the required motor vehicle license, commensurate with the class and type of vehicles they operate, rests with the Appointing Authority.

- 1. NJAC 4A: 4-2.3(b) states that all requirements must be met as of the closing date.
- 2. Online applications must be completed and submitted by the closing date listed above.
- 3. You must complete your application in detail. Your score may be based on a comparison of your background with the job requirements. Failure to complete your application properly may lower your score or cause you to fail
 - NOTE: Auto-fill may cause incomplete information on your application. Please confirm your name, address and phone number prior to submitting your application.
- 4. If an employment list results from this announcement, it may be certified to fill full-time and part-time positions.
- 5. Effective September 1, 2011, the New Jersey First residency law was enacted. Please click here for additional information.
